- Novice B, Novice A, Novice long sits and downs (Novice B & A may be combined)
- Beginner Novice B, Beginner Novice A (Optional Titling Class)

**Rally class run order**

- Masters C, B, A
- Excellent C, B, A
- Advanced C, B, A
- Novice C, B, A

Class run order may be changed at Judge's discretion

**Obedience/Rally Awards/Ribbons:** 1st thru 4th place and green qualifying or x qualifying ribbons will be awarded when applicable. Rosettes will be given for HIT, High Combined, HIT Aussie, HIT Other Breed and HIT Junior Handler. Dogs must receive a qualifying score to receive a ribbon. New title ribbons awarded to all dogs completing titles in Rally or Obedience.  
***HIGH POINT Obedience & Rally Awards to highest combined scores from both trials to be awarded after Sun PM BOB, must be entered in both obedience or rally trials to be eligible.***

ASCA® Performance Titles. A Tracking number is required for obedience/rally competition. Rules and forms can be found at <http://www.asca.org/formsandrulebooks>. A dog will be allowed to be shown at the trial where the handler applies for an ASCA® tracking number. No dog without an ASCA® individual registration, LEP number or ASCA® tracking number may compete in any ASCA® Obedience Trial.

### ATTENTION EXHIBITORS: CASC RULES AND REGULATIONS

- These shows will be judged and run by the Show Rules of the Australian Shepherd Club of America.
- All entries must be complete (with agreement signed) or they will be refused. All dogs must have ASCA registration or tracking number on entry form. Entries must be on the current ASCA entry form.
- Incorrect and/or missing information will invalidate entries.
- Judges may be substituted.
- No bitches in season allowed to compete.
- There will be no food vendor at these shows.
- No electrical and/or mechanical training devices will be permitted on the show grounds.
- Entry fees will not be refunded in the event a dog is absent, disqualified, excused, or barred from competition by action of the show committee. Entry fees will only be refunded if the refund request is received before the pre-entry closing date. Substitutions allowed with dogs that you own or co-own. ·No entry fee will be refunded if the show cannot be opened or completed by reasons of riots, civil disturbances, fire, Acts of God, or public emergency.
- Exhibitors are responsible for the behavior of their dogs and/or guests and family members. Any Exhibitor whose dog and/or guests/family members create an unnecessary disturbance or engage in unsafe or disruptive behavior may, at the direction of the trial committee or CASC board member, be asked to leave the show site. In such case, no refund of any entries fees will be made. The facility, show-giving club, the Show Chairman, their agents, officers and/or committee assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers or to any of their dogs or property and further assumes no responsibility for injury to spectators.
- All dogs must be on leash or confined to a crate/x-pen at all times except while in the ring during competition. Dogs must be on leash to and from parking area to show ring. Dogs in an x-pen must be attended at all times.
- Exhibitors are responsible for cleaning up after your dogs. Failure to do so will result in excusal from trial and forfeiture of entry fees.
- No entry shall be accepted from a dog or handler disqualified from the ASCA rally program, a dog or handler disqualified from all ASCA programs and a person not in good standing with ASCA.
- For the safety of your dogs and others, all dogs must have current vaccinations against rabies. You are asked to bring a copy of the rabies certificate with you.

These shows are held outdoors on grass, set up may begin at 7:00am Sat and all exhibitors and club members must be off premises by sundown on Sun. night. No overnight camping is allowed and no RV hook up or amenities. There are limited electrical outlets near rest rooms. Bathrooms open at 8:00am Sat and 9:00am Sun. There are alternate bathrooms on either end of the Port of Kalama that are open earlier. You may leave your set ups up over night at your own risk, the sprinkling system is on every other night so don't leave anything you can't get wet. Cascade ASC or Port of Kalama will not be responsible for any missing or lost items. All dogs must be on a leash or confined to a crate at all times except while in the ring during competition. Dogs must be on leash to and from parking area to show ring / grooming area. Dogs that are on a grooming table must be attended at all times. All dogs must be current on Rabies Vaccinations, and proof must be available for inspection by the show committee. Any owners not in compliance with these regulations will be asked to leave the grounds. No refund of any event fees will be given. We will not have a photographer on site.
